## School Nutrition Programs Administrative Board Report

Report Date: October 21, 2024

### **Finance**

This September we fed 12,857 breakfasts, 35,460 lunches and 2,637 snacks over 16 days. Our average daily participation has shown a decrease. I believe this to be mostly due to not serving kindergarten and not having free breakfast for our elementary students. It is tough to see the decrease and I am working on making budget amendments to reflect the updated numbers.

### Free & Reduced Eligibility

Great news! Our free & reduced percentage is just over 62%. Carryover ended the second week of October so don't expect the same number for next month. September is typically the highest percent for the year.

Our SDE announced that Medicaid and Foster students were not getting imported to our Direct Certification system but has been fixed. They anticipate seeing more students qualifying now that this glitch has been addressed.

#### **USDA Final Rule**

Next school year, we can anticipate a change in the meal pattern. USDA has updated the regulations to now address product based added sugars, even lower sodium limits and a very strict "Buy American" guideline. With these changes it is nearly impossible to properly serve our customers. USDA has set up all SFA (School Food Authorities) to fail in one form or another. In every single setting where USDA has an ear, they have been told how this is going to affect our programs and ultimately lead to program failure. The only thing we can do now is hold on to the seat of our pants.

Here is a <u>comparison</u> of what our rules are this year vs next year. Please take a glance. What this means for us is we have to overhaul our full menu down to the <u>ingredients</u> starting in our food bid procedure. This is going to take a lot of time and a lot of knowledge.
