He stated that the results received reflected 5 Improvement Required (IR) schools. He said the IR result for Carrillo ES was anticipated by administration and stated that the Kindred ES result was close to passing. He informed that the district's 3 middle schools met standard, but based on a new rule adopted by the commissioner on July 20, 2018, they automatically defaulted into "failure". He advised that administration would provide a complete report at the next board meeting. The Superintendent discussed the transportation guidelines adopted last year by the board. He stated that this year if there are available seats on a bus, students living inside of 2 miles may apply to ride the bus. This will be in effect about 2 weeks after school starts.
