 - 6. Moved by Steeves, seconded by Boudreau, to approve Policy 418: Drug-Free Workplace/Drug-Free School. Moved by Moore, seconded by Boudreau, to amend Policy 418 by adding the words to page 418-5, VI.A.2: "refer students 18 or over to local resources where students may obtain..." and at the end of the paragraph add the following paragraph: "Refer students under 18, with parental/guardian knowledge and consent, to local resources where students may obtain medically accurate information about cannabis use and substance use, including but not limited to the use of fentanyl or mixtures containing fentanyl, and treatment for a substance use disorder.." The amendment failed 2-4 (with Boudreau and Moore voting in favor, and Knudson, Steeves, Wolff, and Bellingham voting against). Moved by Moore, seconded by Boudreau, to amend Policy 418 by adding on page 418-6, VII.A.2: add "Students 18 or over may be referred to drug or alcohol assistance..." and add an additional paragraph at the end: "Students under 18, with parental/guardian knowledge and consent, may be referred to drug or alcohol assistance or rehabilitation programs; school based mental health services, mentoring and counseling, including early identification of mental health symptoms, drug use and violence and appropriate referral to direct individual or group counselling services, which may be provided by school based mental health service providers; and/or referral to law enforcement officials when appropriate." The amendment failed 2-4 (with Boudreau and Moore voting in favor, and Knudson, Steeves, Wolff, and Bellingham voting against). The main motion passed after discussion 5-1 (with Moore voting against).
 - 7. Moved by Boudreau, seconded by Steves, to approve Policy 515: Protection and Privacy of Pupil Records. Moved by Boudreau, seconded by Moore, to amend Policy 515 on page 515-24, VIII. B. Private Records Not Accessible to Parent, after language of 1. e. insert:
 - "2. Upon parental request, the "Responsible authority must not conceal or deliberately withhold information to a parent regarding their minor child's:
 - a. request to use a different name or pronoun to be recognized as a different gender, or
 - b. request to receive gender-affirming care that involves medical interventions including but
 - not limited to, puberty blocking medications, hormone injections, or sex altering surgeries."

Moved by Wolff, seconded by Knudson, to refer Policy 515 to the Policy Committee and to legal counsel. The motion passed after discussion 5-1 (with Moore voting against).

- 11. Moved by Boudreau, seconded by Bellingham, to approve Policy 721: Uniform Grant Guidance Policy Regarding Federal Revenue Sources. The motion passed by roll call vote after discussion 5-1 (with Boudreau abstaining, Knudson, Steeve, Wolff, and Bellingham voting in favor, and Moore voting against).
- D. Moved by Boudreau, seconded by Wolff, to approve the second reading of rescission of Policy 537: Positive School Expectations Policy. The motion passed unanimously 6-0.
