ELIGIBILITY FOR ATTENDANCE ADMISSIONS

~~All public schools organized within Three Rivers School District shall be free to all students between the ages of 5 and 21 whose parents or guardians reside within the boundaries of the school district or who qualify as homeless residents in accordance with Oregon statute. No student shall be excluded from admission solely because the student does not have a fixed residence or is not under the supervision of a parent.~~

- ~~1. Any student whose fifth birthday falls on or before September 1 may enter kindergarten, and any student whose sixth birthday falls on or before September 1 may enter the first grade at the opening of school in September of the same year.~~
 - ~~a. Minimum age requirements shall be waived for any student who has been attending public school in a state or area which has an entrance age different from that of Oregon.~~
 - ~~b. A student enrolling from a private school will be entered in kindergarten or first grade according to state mandated age requirements unless, after observation, the principal determines developmentally appropriate placement of the student should be at the next grade level.~~
 - ~~c. A student enrolling from a state-registered private school will be entered in grades two through eight according to appropriate grade sequence.~~
 - ~~d. A student enrolling from a private school that is not registered with the state will be placed, taking into consideration the student's age, test scores, observations and/or parental wishes, at the appropriate grade level according to the judgment of the school.~~

~~Students, upon entering public school at the kindergarten or first grade level in Three Rivers School District, shall present an official record of birth. If such is not presented, the parent or guardian shall not be allowed to enroll the student in school. Students who are identified as homeless under McKinney-Vento guidelines shall be allowed to enroll while birth records are acquired.~~

~~Students located in the district shall not be excluded from admission when they are otherwise eligible, not receiving special education, and not yet attained the age of 19 prior to the beginning of the current school year. Students who turn 19 years of age during the school year shall continue to be eligible to attend through the remainder of the school year.~~

~~The district may admit an otherwise eligible person who is not receiving special education and who has not yet attained 21 years of age prior to the beginning of the current school year if the person is shown to be in need of additional education in order to secure a diploma.~~

~~The Board will deny regular school admission to students who have become residents and who are under expulsion from another school district for reasons other than a weapons policy violation. The Board will admit students to appropriate alternative programs.~~

~~The Board will deny for at least one calendar year from the date of the expulsion regular school admission to students who have become residents and who are under expulsion from another school district for a weapons policy violation. The Board may provide alternative programs of instruction to students expelled for a weapons violation.~~

All students attending Three Rivers School District must meet the rules and regulations of the Oregon Board of Education and be in compliance with Oregon statutes.

The Board is committed to providing an educational program for all students living in the district. The Board believes all students living in the district who have not completed 12 years of education should attend school regularly and be included in the available educational programs.

State law requires students to be age six on or before September 1 to enter first grade; and age five on or before September 1 to enter kindergarten.

All new students must register in the office. Registration requirements include proof of the student's birth date (a birth certificate) and immunization records as required by law. Students admitted to any grade must show evidence of completing the prior school years.

Students enrolled in the district shall comply with Oregon laws related to age, residence, health and immunization.

Students located in the district shall not be excluded from admission solely because the student does not have a fixed place of residence or solely because the student is not under the supervision of a parent.

Students located in the district shall not be excluded from admission where they are otherwise eligible, not receiving special education, and not yet attained the age of 19 prior to the beginning of the current school year.

The district may admit an otherwise eligible person who is not receiving special education and who has not yet attained 21 years of age prior to the beginning of the current school year if the person is shown to be in need of additional education in order to secure a diploma.
