2. This Board estimates the necessary cost of the project to be Fifteen Million Four Hundre Eighty-Five Thousand Dollars (\$15,485,000); and
3. It will be necessary for the District to borrow the sum of Fifteen Million Four Hundre Eighty-Five Thousand Dollars (\$15,485,000) and issue the bonds of the District therefor, the remaining fund to be derived from the investment of the bond proceeds; and
4. This Board intends to submit one proposition at a special election to be held on Tuesday May 6, 2014; and
5. On or before 4:00 p.m. on Tuesday, February 25, 2014, the Board shall certify any ballo proposition to be submitted to the voters at such election to the election coordinator designated to conduct elections within the District (the "Election Coordinator").
NOW, THEREFORE, BE IT RESOLVED THAT:
1. A special election of the electors of the District be called and held on Tuesday, May 6, 2014
2. The proposition to be voted on at the special election shall be stated on the ballots is substantially the form as set forth in Exhibit "A".
3. The Election Coordinator is requested to:
a. Utilize <u>The Kalamazoo Gazette</u> , a newspaper published or o general circulation within the District, for publication of notices in accordance with the election law requirements.

- b. Utilize ballot proposition summary information, as prepared by legal counsel, in the form of the notice of the last day of registration and notice of election in the form as set forth in Exhibit "B" attached hereto.
- c. Provide a proof copy of the ballot to the District and its legal counsel in sufficient time to allow the ballot to be proofread prior to printing.
- 4. This Board estimates the period of usefulness of the improvements for which bonds of the District in the amount of Fifteen Million Four Hundred Eighty-Five Thousand Dollars (\$15,485,000) are to be issued to be not less than eleven (11) years.
- 5. The Secretary of this Board is hereby authorized and directed to file a copy of this resolution with the Election Coordinator and with any Election Clerk or clerks designated to conduct elections within the District by 4:00 p.m., on Tuesday, February 25, 2014.
- 6. All resolutions and parts of resolutions insofar as they conflict with the provisions of this resolution be and the same are hereby rescinded.

BONDING PROPOSAL

The following is for informational purposes only:

The estimated millage that will be levied for the proposed bonds in 2014 is 1.5 mills (\$1.50 on each \$1,000 of taxable valuation). The maximum number of years the bonds may be outstanding for any single series, exclusive of any refunding, is eleven (11) years. The estimated simple average annual millage anticipated to be required to retire this bond debt is 2.79 mills (\$2.79 on each \$1,000 of taxable valuation).

(Pursuant to State law, expenditure of bond proceeds must be audited, and the proceeds cannot be used for repair or maintenance costs, teacher, administrator or employee salaries, or other operating expenses.)
