There are numerous factors that can be considered for our low test results in English I,
English II and Algebra I. One factor that stands out more than any are the number of first
time testers in Ozona compared to the state first time testers. We seem to lose a lot of ground in this area. We are targeting this area by having an enrichment class for some of our freshmen and a few sophomores. Attendance is still and issue. Right at 50\% of the students that failed an EOC Test had at least 10 absences or more, which amounts to missing school for at least two weeks. We have in place incentives for students to be in school and pass the EOC's. Students that pass EOC's and have good attendance will be eligible to have a long lunch and not have to report to tutorials. Students with a semester average higher than 70 have a chance to be eligible for semester exam exemptions as long as they do not have any absences. Any student with an unexcused absence will NOT be exempt.
