Section 1: Pursuant to the applicable provisions of the Texas Education Code,
Rules of the Commissioner of Education, and/or the State Board of Education, the Budget
for the 2007-2008 fiscal year of the District (General, Child Nutrition and Debt Service

Funds), a true and correct copy of which is attached and incorporated herein by reference, containing estimates of resources and revenues for the year from all of the various sources; the projects, operations, activities, and purchases proposed to be made and undertaken during the year, together with the estimated costs thereof; and estimated amounts of all other proposed expenditures be, and is hereby, approved and adopted.

Section 2: There is hereby appropriated from the funds indicated and for such purposes, respectively, such funds as may be required for the accomplishment of each of the projects, operations, activities, purchases, and other expenditures proposed in such budget, not to exceed such payment proposed for any department or campus, or the total amount of the estimated costs of the projects, operations, activities, purchases, and other expenditures proposed for such department or campus at the legally required adoption level of fund and function.

Section 3: It is hereby officially found and determined that the meeting at which this resolution was considered, was open to the public and public notice of the time, place and purposes of the said meeting was given and posted, all as required by Chapter 551, TEX GOV'T CODE, as amended and Sec. 44.004 TEX EDUC CODE, as amended.
