Milk Escalator / De-Escalator Pricing Clause

The pricing quoted is based on June, 2025 Federal Milk Marketing Order for Class I Skim and Class I Butterfat. This pricing is subject to change as the cost of raw milk changes each month according to the USDA Federal Milk Market Price Announcements.

The cost of milk fluctuates up and down each month based on the cost changes in raw milk. Changes of a minimum of \$.15 per CWT (up or down) will move the cost of a half pint \$.001.

Prices will also be adjusted up or down based on cost changes in packaging, ingredients, labor, fuel, juice concentrate, re-sale products.

All price changes will become effective on the 1st day of the month following the price announcement.

To Whom It May Concern:

Putnam County CUSD #535 is requesting bids on white and chocolate milk for the 2025-2026 school year. These sealed bids must be received by 8:30 AM on June 9th, 2025, and will be opened in the District Office.

The successful bidder must furnish refrigerated milk coolers to fit containers that also pass Board of Health inspections. These coolers will be located as follows:

Putnam County High School (Granville)	1 dispenser
Putnam County Junior High (McNabb)	1 dispenser
Putnam County Elementary School (Hennepin)	1 dispenser
Putnam County Primary School (Granville)	2 dispensers

The milk bids are to be quoted on unit cost of ½ pint (8 oz.) containers. The successful bidder must guarantee to furnish milk for the entire school year. The bid should be based on approximately 75,000 ½ pints of white 1% milk and 90,000 ½ pints of chocolate 1% milk.
