Immunization Compliance Project: I continue to track NSBSD students' immunizations through Power School. The district's goal was 95% compliance; currently, we are 99%. Luz and I enter all new immunizations, approve all new enrollments, and send letters for students out of compliance district-wide.

All of the below health numbers are IPK-specific. The medical coverage and documentation level provided at IPK is unavailable at other sites. The nurse is available by phone and email to the village schools; the nurse can drive to BHS, KLC, and HMS for emergency onsite response.

Top three student-specific visits:

- 1) Student #19: 187 visits logged for toileting assistance.
- 2) Student #4: 52 visits logged for behavioral needs; frequently needs a quiet environment during lunch.
- 3) Student #134: 32 visits logged for toileting assistance related to ostomy.

Synopsis of the nurse visit numbers: Our rates of discharges to home related to illness remain lower than in prior years, as are the numbers of OTC medication administrations. Body impacts, stomachaches, and toileting assistance comprise 50% of the nursing visits, while headache, fatigue, and behavior make up another 25%. The average daily visit rate has decreased from 28 to 27 visits, but there has been a 25% increase in students requiring toileting assistance.

Types of conditions that require medications at school: Seizures and severe skin conditions are a few of the medical conditions that require frequent medication administration from the nurse. Less daily medications have been provided this semester compared to last year, with a 50% decrease. Fever, pain, allergic reactions, or stomach discomfort sometimes require asneeded medications when allowed by the parents. Emergency medications for children with anaphylactic reactions or breathing disorders are kept at the nurse's station for emergency administration.

Contagious conditions: A respiratory virus circulated, leading to a dry hacking cough that lasted 3-4 weeks with some students. Also, the pink eye was spreading through the school for a few months. There was a whooping cough in a village and an outbreak within the State that didn't spread on the slope. I believe the North Slope vaccine rates continue to protect our community from vaccine-preventable diseases.

Lice screenings: Back-to-school lice screening were done on a case-by-case basis at IPK, but no classroom-specific screenings were performed.

Notable off-site visits: BHS admin called me to the school for a student with a severe lower extremity infection. Due to a prior traumatic visit, the student and parent were apprehensive about being seen by a provider. Per the parents' request, I escorted them to the ER and stayed through their visit. I also was present during the visit with the specialist. The procedure was successful, and the student returned to school.

Food Allergies: IPK has three students with emergency response med orders for Epi; BHS has none, and HMS has one student with Epi medications. Allergy lists for all 11 schools were completed, and the list was forwarded to the pertinent staff in each school. The list was imported into a Google Doc for dietary and staff access as needed. Parents can call to provide allergy updates, and the Google doc is changed immediately. One significant allergy incident was reported regarding a child eating a yogurt supplied by the teacher, and the student had a milk allergy. The administration was made aware, and a report was submitted.

Staff training: Nursing facilitated getting 23 NSBSD staff trained in adult/child first aid and CPR through Ilisagvik College.

Initiatives: During the 2023-2024 Legislative session **HB 202** was passed and signed into law in August. This bill impacts all public schools in Alaska. It requires:

- That schools have two doses of an opioid overdose drug on school site.
- That schools have at least one staff trained to administer naloxone and at least one dose of the opioid overdose drug on school sites during school days.
