1. 2022-23 Tentative Budget Presentation – Todd Latham
Todd Latham shared the tentative budget, which shows some changes from the draft budget. Overall, we are looking at a revenue increase of about \$277,855 and a decrease in expenses of about \$363,954. Going forward, we will work on the final budget. We will have final staffing costs and make any other adjustments that are needed. The final budget will be brought forward for approval, then we will have the Truth in Taxation Hearing on September 26. The Board would then vote on the final

There is talk of a special session that might be called by the Governor that would be focused on reproductive rights more than anything else.
