1. Sand existing wood flooring using special gymnasium sanders having attached riders to assure even, uniform finished surface. Apply sealer coats with buffing and tacking between and before painting and applying the finish coats.

Game lines to include: Main Basketball, Main Volleyball, (2x) Cross Basketball, (2x) Cross Volleyball, (6x) Free Throw Stubs, (8x) 40' of 1" tan lines, (1x) 4 color Raccoon logo inside the 12' circle (approximately 5' tall), 3' border all the way around with 26" letters "MacArthur (1 end) & "Marauders" (Other end).
