BACKGROUND INFORMATION:

- Borman: The scope of this project is a new three classroom addition with a bank of group restrooms. Also included in this project scope are renovations to classrooms, changing the folding walls to permanent walls, administration renovation and new entrance with security lock vestibule. Alternate #2 is for adding new marker boards and tack boards to each existing classroom. Alternate #3B is for Aaon mechanical equipment.

N. Rayzor: The scope of this project is a new six classroom addition with a bank of group restrooms. Also included in this project scope are increasing the size of the library, renovation to existing classrooms to accommodate special programs, and renovating the existing administration area and providing a new entrance with security lock vestibule. Alternate #2 is for painting the exterior "blue" plaster a new color which will blend with the existing exterior color scheme. Alternate #5B is for Aaon mechanical equipment.
