## PLAN OF ACTION

Gale Pond Alamo Elementary exceeds the cap by one student in kindergarten. Gale Pond Alamo is a total magnet school. One student was placed in a bilingual classroom upon registration but should have been placed in a regular classroom. Moving the student to the appropriate classroom caused the campus to exceed the cap by one student in kindergarten. Normal attrition should balance the class by the end of the semester.

Blackshear Elementary exceeds the cap by four students in kindergarten. The magnet configuration of the campus will allow the campus some control in the enrollment of students. The District continues to work with a demographer to redraw boundary lines for elementary campuses. These new boundaries will be presented to the local Board of Trustees this year with implementation scheduled for the Fall of 2011.

Burleson Elementary exceeds the cap by one student in first grade, two students in third grade, and one student in fourth grade. The District continues to work with a demographer to redraw boundary lines for elementary campuses. These new boundaries will be presented to the local Board of Trustees this year with implementation scheduled for the Fall of 2011. Normal attrition should balance first grade and fourth grade by the end of the semester.

Cavazos Elementary exceeds the cap by three students in first grade and one student in third grade. The campus has been closed to all students unable to produce proof of residency within the Cavazos boundaries. The District continues to work with a demographer to redraw boundary lines for elementary campuses. These new boundaries will be presented to the local Board of Trustees this year with implementation scheduled for the Fall of 2011.

Murry Fly Elementary exceeds the cap by one student in fourth grade. The campus has been closed to all students unable to produce proof of residency within the Murry Fly boundaries. The District continues to work with a demographer to redraw boundary lines for elementary campuses. These new boundaries will be presented to the local Board of Trustees this year with implementation scheduled for the Fall of 2011.

Goliad Elementary exceeds the cap by four students in kindergarten. The District continues to work with a demographer to redraw boundary lines for elementary campuses. These new boundaries will be presented to the local Board of Trustees this year with implementation scheduled for the Fall of 2011.

Gonzales Elementary exceeds the cap by one student in kindergarten. Normal attrition should balance the class by the end of the semester.

Hays exceeds the cap by three students in first grade. Hays is a total magnet school that recently converted to an academic magnet program. The campus has historically had very low enrollment. In order to increase the enrollment, the campus administrator enrolled first grade siblings after reaching the cap in order to provide needed growth at other grade levels. First grade enrollment will be monitored and another teacher will be added if enrollment at first grade continues to grow.

Ireland Elementary exceeds the cap by three students in kindergarten and three students in first grade. The magnet configuration of the campus will allow the campus some control in the enrollment of students. The District continues to work with a demographer to redraw boundary lines for elementary campuses. These new boundaries will be presented to the local Board of Trustees this year with implementation scheduled for the Fall of 2011.

Sam Houston Elementary exceeds the cap by two students in third grade. The District continues to work with a demographer to redraw boundary lines for elementary campuses. These new boundaries will be presented to the local Board of Trustees this year with implementation scheduled for the Fall of 2011.

Travis Elementary exceeds the cap by two students in a fourth grade bilingual class. The magnet configuration of the campus will allow the campus some control in the enrollment of students. The District continues to work with a demographer to redraw boundary lines for elementary campuses. These new boundaries will be presented to the local Board of Trustees this year with implementation scheduled for the Fall of 2011. A bilingual instructional aide has been assigned to this class to assist the teacher.
