Notice of Vacancy-Board of Education

The Board of Education of River Forest School District 90 hereby gives notice that it will accept letters of interest from individuals who would like to be considered for appointment by the Board to fill a vacancy created by the resignation of one of the school board members. The successful applicant for the position will serve until the April 2019 Consolidated Election at which time a successor would be elected to fill the unexpired term for the position. The successful applicant would be eligible to run for election at the April 2019 Consolidated Election.

A candidate for the position **must** meet all legal requirements for holding the office of school board member. The applicant must be a citizen of the United States of the age of 18 years or over, shall be a resident of the State of Illinois and of River Forest School District 90 for at least one year, and shall be a registered voter as provided by the general election law.

Letters of Interest should include:

1. Reasons for applying; and
2. Proof of legal qualifications.

A candidate may also wish to include the following in their letter of interest (where applicable):

1. List any involvement in River Forest School District 90 public schools and/or other background in education;
2. List any history of participation in community activities;
3. List any suggested goals for the Board of Education and the School District if appointed; and
4. State educational and employment background.
