1. Assignment of District Accreditation Status

2. Recommended School Performance Classifications

You are hereby notified that on September 6, 2007, the Commission on School Accreditation assigned your school district an **Accredited** status for school year 2007-2008. The decision of the Commission was based on the information stated on the enclosed 2006-2007 Accreditation Record Summary in accordance with current accreditation policies 2.1, 2.2, and 2.3, as published in *Mississippi Public School Accountability Standards*, 2007.

As stated in accreditation policy 2.5, an assigned district accreditation status may remain unchanged during that school year except in those cases where verified noncompliance with financial standards, the testing standard, continued noncompliance with federal regulations, or reporting false information may downgrade a status immediately. When the district has verified correction of deficiencies in meeting all process standards previously cited as deficiencies on the district's Accreditation Record Summary, the accreditation status will be upgraded. Action of the Commission is required in either case.

You are also notified that on September 6, 2007, the Commission on School Accreditation assigned school performance classifications to each school in your district for school year 2007-2008. The decision of the Commission was based on the information on the School Performance Reports and in accordance with accreditation policies 3.1 and 3.3, as published in Mississippi Public School Accountability Standards, 2007. The recommendations for school performance classifications are reflected in the final report mailed to you on August 31, 2007.
