BACKGROUND INFORMATION:

State statute requires that changes in the Budget adopted by the School Board at their June 2011 meeting (and amended on September 12, December 12, February 13, March 19, and May 14) must be approved by the School Board if they change the major revenue sections or if they move money between expenditure functions.

At the end of each year, school district's typically make adjustments in their budgets to ensure that each budget function has a sufficient budget to support its expenditures.

The attached budget amendment being submitted to the board makes the following transfer in the budget:

Transfers \$122,518 from Function 51 (Maintenance) which will have surplus funds in its budget to Function 11 (Instruction) to fund additional CATE expenses that we will incur because of the change made by the Auditor last fall as to how our computer lab expenses could be allocated.

Transfers \$10,000 from Function 51 (Maintenance) to Function 12 (Instructional Media/Library) to cover a budget shortfall that is expected in Function 12.
