WHEREAS, the Board is making this resolution for purpose of authorizing the donation of the Property;

RESOLVED, that the Board of Trustees of Chico Independent School District donates the Property to the City of Chico, as authorized by Texas Education Code section 11.1541; and be it further

RESOLVED, that the undersigned President of the Board of Trustees of Chico ISD is authorized and directed to execute any and all instruments appropriate or necessary to effectuate the donation of the Property.


