Martin and Melissa --

I've just requested that our business manager develop an agreement to conduct a policy review session for Brownsville ISD. You all are a big district with a complex manual, so we're predicting a fairly lengthy period of time for preparation, our face-to-face meeting, and revising and editing after that meeting.

Here are some rough predictions for cost:

Base cost for a policy review session: \$3,500 Additional hourly costs for consultant preparation, review session, and revision: \$2,000 Consultant travel: \$700 Editing and Printing \$1,000

These are estimates only. Once my business manager and I have a chance to talk about the project, we may adjust this estimate. The estimate of costs we include in the agreement will be more accurate and considered than the rough estimate I'm sending in this email.

I will keep track of the hours I work on your PRS, and we will only charge you for the actual hours worked, so if I work fewer than the estimated hours, your charges will be less than the estimate.
