- We still have some things to work out as space is becoming constrained in a number of our sites, such as Lester Park, Homecroft, and Myers-Wilkins.

### **Duluth Promise Update**

 Our collaborative team with representatives from the University of Minnesota-Duluth, the College of St. Scholastica, Lake Superior College, the Duluth Superior Area Chamber of Commerce, City of Duluth Workforce Development, and APEX have been meeting as we continue to develop our robust and collaborative career pathways and partnerships.

• Our team met today for a half-day work session to plan for next steps, including use of the \$50,000 in state funding, and are excited about the direction of this initiative.

### **Board Work Sessions Update**

- On September 9, 2025, School Board Members participated in a Board Retreat for Duluth Public Schools facilitated by Dr. Ray Queener from TeamWorks.
- This retreat built upon the July 8, 2025 retreat, deepening the board's engagement in strengthening governance and modeling professional development as a committed team. Board members demonstrated a strong willingness to be highly engaged, focused on doing the work, and committed to continuous improvement.
- The retreat provided structured opportunities for reflection, practice, and collective learning. Using TeamWorks' governance frameworks, the board examined the role of the chair, practiced productive conversations, reviewed the Transition & Development Framework, clarified commitments to governance culture, and identified key messages to guide their work moving forward.
