Some of the bills reviewed in this category were: HB 6 Discipline and Telehealth Mental Health Services, HB 33 Active Shooter Incidents at School Facilities, HB 1106 Definitions of Child Abuse and Neglect, HB 1458 Armed Security Officers Required at Public Schools, HB 1586 Exemptions from Required Immunizations, SB 57 Ensuring Safety of Disabled Individuals During a Drill, Emergency, or Disaster, SB 571 Reporting and Investigation of Misconduct and Child Abuse and Neglect and SB 920 Administration of Medication by School Employees.
 - 2) Learning Assessment, Accountability & Instruction had 24 Bills. A few of the ones reviewed in this category were: HB 100 Instructional Materials Purchase, Adoption, and Use, HB 2310 Strategic Plan for Young Children with Disabilities, SB 568 Special Education Funding Reform, SB 1191 Standard Method for Calculating High School GPA and SB 2398 Concussions Sustained at a School-related Activity other than an Interscholastic Event.
 - 3) Governance District & Charter School Governance & Open Government contains 33 Bills. In this category the Bills reviewed were: HB 117 Establishes Governor's Task Force on Governance of Early Childhood Education, HB 2495 Student and Parent Rights Sole Managing Conservator, HB 2788 Fraud Detection and the Public Information Law, SB 10

- Display of the Ten Commandments in Classrooms, SB 12 Parental Rights and SB 2986 Religious Organization Use of Public-School Facilities.
- 4) Money School Finance & Property Tax in this category there were 28 Bills.
