# BOARD CONSENT AGENDA ITEM April 13, 2021

## Consider Approval of Extended Closures/Missed School Day Waiver

## **SUMMARY:**

This item requests approval to apply for a Missed School Day waiver from the Texas Education Agency (TEA) in accordance with the *TEA Inclement Weather Update*, dated March 4, 2021. The Missed School Day waiver applies to a complete campus/LEA closure when no instruction was provided.

The Denton ISD (all campuses) was completely closed from Tuesday, February 16, 2021, through Friday, February 19, 2021, which were instructional days as assigned by our 2020 – 2021 school calendar (modified/approved on December 15, 2021).

Several campuses incurred extensive damage requiring additional school day closures during the week of February 22, 2021. This consent agenda item requests approval to apply for a Missed School Day waiver for these campuses and specific dates as well.
