Mr. Cesar Vela, Vice President of Finance & Administration, noted that Administration is proposing the no new revenue rate of \$0.229249, and by adopting this rate, no public hearings are needed. He also noted that the debt service rate would be \$0.34470, and the M & O rate would be \$0.194779 for a total of \$0.229249.
