# Superintendent's Report May 2020 \*\*\*\*

I want to begin by thanking the many people that worked to plan and implement our graduation celebrations. We know that this isn't anything like anyone expected for graduation this year, however, I think the events were special in a different way. Our staff and student leaders really did an excellent job of coordinating the events. All of these events will be brought together in a televised event. These will be shown on WDSE for all the family, friends, and the whole community to share. We will share the schedule of these showings soon. The Aeriel lift bridge will also be lit in honor of our graduates and each school has a night for the bridge to don their school colors. Thank you again to all the people that made this possible and to WDSE, the CIty of Duluth, and other community organizations that have made this all possible.

The Goldfine Goldstar Teacher Award Celebration is an annual event we look forward to each year. It was started by Lillian and Manny Goldfine in 2007. It provides us with a fun

opportunity to celebrate the amazing work of teachers from across the district. The award rotates between elementary and secondary schools from year to year. This year we will be celebrating secondary school teachers. This year's nominees include Ed Lewis from Denfeld, Kim Olson from East (and Denfeld), Doug Antonich from Ordean-East, Katie Britton from Lincoln, Scott Forbort from ALC/AEO, and Barb Paquette from our residential sites. We are planning for Summer Keyzone-- this will start on June 15th. The Governor's Executive Orders require us to prioritize child care services for families working in identified fields. Registration is going on now and more information can be found on our website. Availability will be limited based on our ability to have enough space for social distancing. We will be continuing our efforts to ensure the safety of everyone involved.

Each year the Fred HASE Memorial Scholarship is granted to two students-- one from Denfeld, and one from East. The scholarships are determined by random drawing-- so we have this crystal bowl donated by the family to do the drawings each year. Usually we have our student school board representatives make the drawing but tonight that isn't possible so I will be doing the drawings. Right now, the names of all of the Denfeld seniors are in the bowl--- and the winner is Jamie Burwell. I will also draw two alternate names just in case. And now I will change the names out for all of our East seniors. And the winner is Mckenna Kolasinski. And again, I will draw two alternates.

And finally, it is time to hear from our student school board representatives:

Student Representative Phoenix Ocean (Denfeld): Reported to the board that Tom Tusken was named as the new principal at Denfeld. Several students in the HOSA and Speech programs will be going on to state competitions. Graduating seniors were given yard signs and caps and gowns by staff members.

Student Representative Nabiha Imtiaz (East): Reported to the board that seniors had a drive through at East to pick up their gowns, yearbooks, etc. and that seniors were very happy with it. Remaining grades will also have a drive through to drop off books, etc. AP exams are being held. Mix 108 had a virtual prom. Students in History Day and HOSA events won awards.

# RESOLUTION DECLARING THE FIRST FRIDAY IN JUNE TO BE NATIONAL GUN VIOLENCE AWARENESS DAY

This resolution declares the first Friday in June to be National Gun Violence Awareness Day in the Duluth School District to honor and remember all victims and survivors of gun violence and to declare that we as a country must do more to reduce gun violence.

**WHEREAS**, every day, more than 100 Americans are killed by gun violence and on average there are more than 13,000 gun homicides every year; and

**WHEREAS**, Americans are 25 times more likely to die by gun homicide than people in other high-income countries; and

WHEREAS, Minnesota has hundreds of gun deaths every year; and

**WHEREAS**, protecting public safety in the communities they serve is a high priority of the school district; and

**WHEREAS**, support for the Second Amendment rights of law-abiding citizens goes hand-in-hand with responsible gun ownership; and

**WHEREAS**, the pandemic facing America has drastically impacted communities and individuals sheltering in place which may result in situations where access to firearms results in increased risk in intimate partner violence gun deaths, suicide by gun and unintentional shootings;

**WHEREAS**, in January 2013, Hadiya Pendleton, a teenager who marched in the presidential inaugural parade and was tragically shot and killed just weeks later, should be now celebrating her 23rd birthday; and

**WHEREAS**, to help honor Hadiya – and the more than 100 Americans whose lives are cut short every day and the countless survivors who are injured by shootings every day – a national coalition of organizations has designated June 5, 2020, the first Friday in June, as the 6th National Gun Violence Awareness Day; and

**WHEREAS**, the idea was inspired by a group of Hadiya's friends, who asked their classmates to commemorate her life by wearing orange; they chose this color because hunters wear orange to announce themselves to other hunters when out in the woods and orange is a color that symbolizes the value of human life; and

**WHEREAS**, anyone can join this campaign by pledging to Wear Orange on June 5th, the first Friday in June in 2020, to help raise awareness about gun violence; and

**WHEREAS**, by wearing orange on June 5, 2020 Americans will raise awareness about gun violence and honor the lives of gun violence victims and survivors; and

**WHEREAS**, we renew our commitment to reduce gun violence and pledge to do all we can to keep firearms out of the wrong hands, and encourage responsible gun ownership to help keep our children safe.

**NOW, THEREFORE BE IT RESOLVED**, that the Duluth School Board declares the first Friday in June, June 5, 2020, to be National Gun Violence Awareness Day. We encourage all schools to support their local communities' efforts to prevent the tragic effects of gun violence and to honor and value human lives.
