Facts of this Matter:

Many of our school-owned instruments are over 20 years old and are used by several students every day of the year. With this much use, all our 3/4-size cellos need to be replaced. Replacing our most used instruments will reduce the number of repairs needed throughout the year and will also allow us to provide high quality instruments for our students to use daily. High quality instruments directly benefit the success of our students in instrumental courses.

In addition to replacing six 3/4-size cellos, we would also like to replace a 1/4-size bass that needs frequent repairs, will not stay in tune, and is hard for students to play.
