**Call to Order** – The Board President called the meeting to order at 6pm.

**Roll Call** – The Board President called the roll of members. All members were present.

<u>Canvass the Results of the November 3, 2020 Board of Trustees Election</u> – The election returns certified by the election officials were given to the Board of Trustees. The Board canvassed the returns and Vice-President Alan Hemphill declared the results of the November 3, 2020 as follows: Mr. Chris Hinnant, winner of Place 1 and Mr. Grant Gutierrez, winner of Place 2.

<u>Administer Statement of Officer to Elected Trustees</u> – Article XVI, section 1 of the Texas Constitution requires all elected or appointed state and local officers to take the official oath of office and to subscribe to the anti-bribery statement (Form 2201-Statement of Officer) before entering upon the duties of their office. Mr. Hinnant and Mr. Gutierrez signed the Statement of Officer.

<u>Administer Oath of Office to Newly Elected or Newly Re-elected Board Members</u> – Denise Behrens, acting in her capacity as a public notary, administered the oath of office for the newly elected School Board Trustees.

Reorganization of the Board of Trustees – Board policies BDAA [Legal] and BDAA [Local] specify that the Board will elect a president, vice-president, and secretary at the first meeting after each election and qualification of Trustees. Candice Parsons nominated Alan Hemphill as president. No more nominations were received, and nominations ceased. Mr. Hemphill was elected president with a 7-0 vote. Nancy Towry nominated Candice Parsons as vice-president. No more nominations were received, and nominations ceased. Mrs. Parsons was elected vice-president with a unanimous 7-0 vote. Alan Hemphill nominated Nancy Towry as secretary. No more nominations were received, and nominations ceased. Mrs. Towry was elected secretary with a 7-0 vote.

<u>Public Communications</u> – The Board heard from Erik McCowan regarding the solar energy project proposed by Big Star Solar, LLC. They also heard from Dave Fehlker, Brenda Fehlker, Katie Fehlker, Lelia Joy, Kelly Wakely-Brown and Claire McMillin-Albin regarding their concerns about returning to face-to-face learning. The Board heard from Leona Jones, a teacher at Smithville High School, who expressed her support of in-person learning. In addition, the Board heard from Michele Rutherford supporting the use of face coverings with strict monitoring of their use, and delaying the start of school until two weeks after January 1, 2021.

<u>Consent Agenda</u> – Howard Burns, Jr. moved to approve the Consent Agenda as presented. Grant Gutierrez seconded and the motion passed 7-0.
