Pete Amy stated that he placed a call to Melinda James to find out for sure if the District paid for any part of the sign but she wasn't available due to her being at a conference.

Dr. Martinez stated that Melinda James shared that there are no current funds available at this time. A budget amendment would need to take place before any purchase. The current bids that she brought to the Board are out of date at this time.

Bryan Thomas Muhammad stated that this issue is being prolonged. We can get monies to do everything else. This is being very disrespectful to Coach Breedlove. We need to step up as a Board and move forward. We need to stand up and not be cowardly.

Pete Amy stated that the Board is not being disrespectful and that the Board has addressed this issue at length several times. There was a volunteer on the Board that was going to head this up. We do not need to micro manager every little thing in the District to do this; It isn't the Board's charge or responsibility. We have rules, policies and the Board's Operating Procedures in place and that's what we need to follow.

Bryan Thomas Muhammad stated that this issue was passed in September. If you don't see this as being disrespectful you may be the disrespectful ones.

Pete Amy stated that respect goes both directions Mr. Muhammad

Ruth Hancock stated that there are people in the community that are willing to donate to this signage. Once it's started that people will donate.

Bryan Thomas Muhammad states that what coach Breedlove has given to this District and to this city there needs to be no donations; he's given enough of

his time his self and his inspiration and if you didn't receive that you wouldn't understand. Those of us who have received benefits of Coach Breedlove would like to see this go forward.
