Basic information:
#1 - The administration is requesting that the Board of Education adopt the <u>Intent to Levy Taxes</u> <u>Resolution</u> at the November 20, 2025, Board of Education meeting.
#2 - The administration is requesting that the Board of Education adopt a <u>resolution to approve the</u>
Aggregate Property Tax Levy on December 18, 2025.
Background or historical information:
Provious decisions actions or parameters that relate to this topic or issue:

revious decisions, actions or parameters that relate to this topic or issue:

- 1. The Intent to Levy Taxes Resolution is presented to the Board of Education for discussion on November 20, 2025.
- $2.\,$ The Resolution must be adopted by the Board of Education (on November 20, 2025) at least 20 days preceding the Adoption of the Aggregate Property Tax Levy (December 18, 2025).
- $3.\,$ A Public Hearing must be held by the Board of Education (December 4, 2025) preceding the adoption of the aggregate levy if the proposed Property Tax Levy exceeds 105% of the previous year's taxes extended.
- 4. Notice of proposed Intent to Levy Taxes Resolution and Public Hearing must be published in a newspaper of general circulation no more than 14 days and no less than 7 days from the date of the Public Hearing to be held by the Board of Education.

- 5. Notice of Public Hearing will be published between November 21, 2025, and November 27, 2025, per Illinois School Code.
- 6. Regularly scheduled Board of Education meeting to hold Public Hearing on December 4, 2025.
- 7. Adopt 2025 Aggregate Property Tax Levy at a regularly convened meeting of the Board of Education on December 18, 2025, after holding the Public Hearing on December 4, 2025.
- 8. Board of Education signs Certificate of Compliance and Certificate of Levy.
- 9. Adopted and signed Property Tax Levy and Certificate of Compliance MUST be filed with DuPage County Clerk by the last Tuesday of December (December 30, 2025).

Timeline:

- 1. November 20th Intent to Levy Taxes resolution presented to BOE. Resolution to Adopt Aggregate Property Tax Levy is presented to BOE.
- 2. November 20th Board adopts Intent to Levy Taxes resolution. Notice of Public Hearing on Intent to Levy Taxes resolution published in local newspaper. *By law, we are required to hold a Public Hearing and post notice of a Public Hearing if the Levy exceeds 105% of last year's Oextension amount.*
- 3. December 4th Public Hearing on Intent to Levy Taxes Resolution.
- 4. December 18th BOE adopts Resolution to Adopt Aggregate Property Tax Levy at BOE meeting.
- 5. BOE signs Certificate of Compliance and Certificate of Levy.
- 6. Prior to December 30th Certificate of Compliance and Certificate of Levy filed with DuPage County Clerk's office.

- #2 The administration recommends that the Board of Education adopt the **Resolution to Adopt the Aggregate Property Tax Levy**.
