#### I. OPEN SESSION

Board President Randy Condra opened the meeting by reading the following statement:

On March 16, 2020, Governor Gregg Abbott granted a request by Attorney General Ken Paxton to temporarily suspend a limited number of open meetings laws to the extent necessary to allow telephonic or videoconference meetings in response to the Coronavirus (COVID-19). In accordance with those suspended rules, Crosby ISD certifies the following:

- a) Notice of this meeting has been posted online, and physically at the District's central administration building, for at least 72 hours.
- b) Although members of the Board are not gathered in a central, physical location, we do have a quorum in attendance at this meeting by telephone conference call.
- c) This meeting is being held by telephone conference because the convening at one location of a quorum of the governmental body is difficult during the COVID-19 Public Health Emergency.
- d) The meeting is audible and accessible to the public in the District's Operations Center, located at 14670 FM 2100 Crosby TX 77532, which is the regular meeting

location of the Crosby ISD Board of Trustees. Persons may also hear and view the board meeting by watching a recording of this meeting on the district's Facebook Page or watching a recording of this meeting from a link on our district's website.

e) Based on current guidance from federal, state, and county authorities concerning large gatherings and social distancing during the COVID-19 public health emergency, the District has limited access to the administration portion of the Board Auditorium to ten (10) people, and to the separate, public portion of the Board Auditorium to ten (10) people. Entry has been permitted on a first come basis. Additional space has been provided in the foyer of the Operations Center.

f) Crosby ISD resource officers are in the Board Auditorium and the Foyer enforcing the social distancing guidelines issued by the Centers for Disease Control and Prevention, and state and local health authorities

- h) All other meeting procedures will adhere to board-adopted procedures to the extent practicable.
