Ms. Tyrer called to order the Board meeting for the purpose of executive session at 5:32 p.m. Ms. Tyrer asked all to stand for the flag salute. Ms. Tyrer suspended the board meeting at 5:33 p.m. to convene executive session.

CALL TO ORDER

Call to Order – Regular

Board Meeting

Ms. Tyrer called to order the regular meeting of the Board of Directors of the Neha-Kah-Nie School District at 6:34 p.m. Ms. Tyrer welcomed staff, students and patrons of the district. All present stood for the flag salute.

Approve Agenda

M-Mahoney/2nd Scalabrin to approve the agenda as presented. Motion carried unanimously.

Habitat Conservation Plan/Forest Management Plan (HCP/FMP) Update, District 32 Representative, Cyrus Javadi, DDS

Mr. Erlebach introduced Representative Javadi. He explained that for several years now the Oregon Department of Forestry (ODF) has been pursuing a HCP, which is an agreement with the Federal government to protect endangered species. It is a benefit to conservation goals to have habitat for the forest animals. It also provided some protections for our timber industry in the event of an accidental "take." Which can result in fines and lawsuits. In agreement with industry, the ODF saw this as a way to minimize that risk. Industry is on board with this; in the event of an accidental "take" there is less liability. If the plan is approved it would go into effect this September.

The current plan has been under review since November. They have been waiting to see what the harvest levels would be. When the harvest levels became known, they were much lower than anticipated. In February, there was a board motion to try to adopt a different alternative that would have less economic impact and still meet the conservation goals. That motion failed. In March, another meeting was held, with several members from affected communities testifying to the impact that the current proposed plan would have on the communities most impacted by the plan. A letter was sent to the Governor alerting her to the impact of the current proposed plan.

Representative Javidi stated that they are waiting to see updated harvest numbers that should be available in June. They are hoping that the harvest levels will be increased significantly and still meet the conservation goals. He also shared that they have seen some movement from the Governor's office to adopt an

alternative plan that would hopefully increase harvest levels by up to ten percent. He should have more information within the next couple of weeks.

Next week members of the public will be able to testify before the legislature. This is not a move to try to push back or curtail conservation efforts. The goal is to take the asset that we have and manage it appropriately, and to sustain industry.

He asked for questions

Mr. Myers thanked Representative Javadi for coming. In the past, board members have written letters stating their opinions on this issue, asked if that is something that would be helpful at this time. Representative Javidi stated that it would be helpful.

Ms. Scalabrin stated that it is exciting that the Governor has opened her mind to allow for greater harvest.

He stated that he is grateful to Mr. Erlebach and Mr. Sybouts for the support and work they have been doing on this issue.

Unfinished Business Preschool Sliding Scale

Preschool Sliding Scale, Janmarie Nugent

Ms. Nugent presented the revised preschool sliding scale. She worked with the adopted sliding scale as if she were a parent and what she found that it was inequitable. In order to qualify for Preschool Promise (PSP) you would need to meet 200 percent of Federal poverty. They increased to 230-300 percent of the Federal poverty level so that more families could qualify for free preschool.

Ms. Scalabrin asked for clarification, she is concerned about overly penalizing parents who would not qualify for PSP.

Ms. Tyrer asked that because we have adopted a sliding scale we will be able to open up to more students. Mr. Erlebach stated that is not correct, the preschool will be capped at 20 student per preschool. Both preschools are already full. Garibaldi has not filled their slots yet until the sliding scale issue has been resolved and parents have been notified of the new sliding scale.

Mr. Myers asked Mr. Erlebach and Mr. Sybouts what is the estimated revenue for the sliding scale. Mr. Erlebach stated that we are not certain of that. The last time we had a sliding scale the revenue received was approximately \$10,000. The district would be happy if we received \$30,000. Currently we take \$160,000 out of the general fund for preschool.

Mr. Myers stated that he voted no on the sliding scale is due to the inequity that it creates.

Ms. Scalabrin is in favor of a sliding scale, but is this the year that we need to adopt a sliding scale.

M-Aeder/2nd Mahoney accept the revised preschool sliding scale as presented. Yes- Mahoney, Scalabrin, Aeder, Tyrer. No - Myers, Wantland. Motion carried with a 4 yes to 2 no vote.

He asked the board to keep in mind that it does take time to prepare the budget resolutions.

Ms. Aeder stated that she feels that we need two AEDs. She went to the high school Hazelton Betty Ford presentation, the students really listened. You can get NARCAN for free at Adventist. ZEN is the new genetically modified vape product that we need to be aware of, and the new pot is not your grandmothers pot, it is so much stronger.

Mr. Myers is wondering if we can have AED that the team can take with them for the remainder of the season. On May 11th the PUD is going to have a career day at the PUD. The school has been notified.

Mr. Wantland mentioned that the community is committed to beautifying the Jim Mudd field. He would like to see the field cleaned up for soccer use. He would like to see us use our fields more.

Sadie Hawkins Dance



3. Proposed next steps

- Partner with families, Work on increased information to homes. Parents are first teachers
 on these topics. Important to provide parental information, age appropriate. For example,
 at elementary level, discuss safe medicines. 3 out of 4 schools have active parent
 groups/councils can share information through/with as well as newsletters.
- Classroom style conversations, coordinating with Health Teachers. Each building is run differently, helps to have assistance at each school to add to what is already taught at the elementary levels.
- Develop Peer Leaders in Middle School and High School. Having students who engage
 in healthy behaviors lead conversations develops momentum. Students feel comfortable
 with students their age.
- Continue science-based information, Students positively received brain information, empowers them to understand why they actually cannot drink responsibly. Increase

protective factors. Not just effective for substance use prevention but aids in prevention of bullying, positive peer pressures, ect.

- 4. Oregon School Nurse Association Conference, the role and scope of the Oregon School Nurse. Often tell people, "I cannot diagnose and treat." This conference highlighted these topics: 504's, eating disorders, chronic health conditions and behavioral health, as well as non-epileptic seizure disorders.
- 5. AED update, athletic department does not have travel AED. Can apply for second grant once NES has received theirs (anticipated end of school year.)
