#### The One-to-One Device Program

The United Independent School District's Board of Trustees is committed to support the District's mission to inspire all students in becoming responsible digital citizens and pursue excellence through lifelong learning experiences. The District's primary intent is to continually seek ways to improve knowledge and skills. The District aims to provide a quality technology-rich instruction, in addition to providing a positive, safe, and collaborative learning environment for all students.

UISD is committed to enhance and enrich all instruction through the use of the most current and trending technology by creating a framework that supports the fostering of each student's potential with technology-infused K-12 Curriculum. This curriculum will help mold them into productive and successful citizens for our community.

The UISD implementation of the 1:1 Device initiative will allow all learners to have an engaging and empowering learning experiences. These experiences will prepare them to be active, creative, knowledgeable, and ethical participants in this fast-paced technology-driven society. In addition, a 1:1 device will allow a student to continue their learning by not limiting the student to the boundaries of a classroom or school building. The parent/guardian's agreement, cooperation and investment in this 1:1 MLD Initiative are vital components of the student's educational success. Any questions or concerns will be addressed by Campus Administrator in charge of the 1:1 MLD Initiative.

United ISD 8th and 9th grade students will receive a Mobile Learning Device (MLD) at no cost for its instructional use during the designated period as assigned to the grade level. A cost of \$241.50 will be incurred only if the device is lost, stolen, or rendered irreparable. District has different payment plans which can be done in cash, money order or the UISD Electronic Payment System. A student will be issued another device upon full payment of the damage/lost device. The cost of repairs that are beyond the scope of the device warranty will need to be covered by the parent/guardian from a reputable United States Vendor of their choice with all accessories purchased from Dell or an authorized Dell product reseller.

#### Agreement Terms

The Parent/Guardian of a UISD student will agree to voluntarily accept the Terms and Conditions of the UISD 1:1 MLD for instructional/academic or any school related purpose. A parent/guardian will not be obligated to have their child participate in this new initiative.

The following are conditions set by UISD for Parents/Guardians and their child/children with regard to the MLD 1:1 Initiative.

It is required as a condition of acceptance, parents/guardians and their child/children will adhere and comply with the requirements set forth in this UISD MLD 1:1 Handbook and the Student Code of Conduct for the District.

It is the policy of United I.S.D. not to discriminate on the basis of race, color, national origin, sex, or handicap in its programs, services, or activities as required by Title VI of the Civil Rights Act of 1964, as amended; Title IX of the Education Amendments of 1972; and Section 504 of the Rehabilitation Act of 1973, as amended.

- ☐ It is understood and agreed upon that the Mobile Learning Device (MLD) is, and shall remain, the property of UISD. This agreement does not constitute any transference of property rights.
- □ Students shall not remove or permit to be removed any original/District tags indicating serial number, model, name, or other indications showing ownership.
- □ Parents/Guardians and students must read and sign the agreement and understand that they are fully responsible for the technology equipment that has been checked out for academic and any other district related activities while he/she is enrolled as a student of the United Independent School District.
- ☐ I will abide by the District's Acceptable Use Guidelines at all times as set forth in UISD Student Code of Conduct, Technology Use Guidelines, or any other Agreement/Permission Forms.

Failure to comply with all the terms of this agreement, as denoted in the Parent/Student MLD Handbook including the return of the MLD at the end of the assigned term and/or at the time of withdrawal from the District, may result in the designated District/Campus administration to use reasonable means to attempt the recovery of the MLD up to and including Information Technology and UISD or Local Law Enforcement.

#### MLD Check-In and Check-Out Process

#### MLD Check-Out

#### **Campus Designed Procedures**

<u>All</u> 8th and 9th grade students will be offered an opportunity to check out a Chromebook as part of the 1:1 MLD Plan. Parents/Guardians may choose to Opt-In or Opt-Out of the MLD Program. While the District highly recommends that every child participate in this initiative, if a parent/guardian chooses not to have their child participate, the campus will make the necessary accommodations for the child that would include, but not be limited to, a hard copy delivery of resources and/or submission of assignments/projects.

Upon completion of the 8th/9th grade Registration process:

- Parents will be notified of a date and time for a required 1:1 MLD Meeting/Training
  - Important information will include:
    - Guidelines and Procedures:
    - Maintenance and Care; and
    - Financial Responsibility for Damaged, Lost or Stolen Devices.
- Parents/Guardians and students must complete all of the following before an MLD can be issued to students.
  - Attend 1:1 MLD Parent Meeting/Training
  - Return signed Student/Parent/Guardian Agreement to Homeroom Teacher
  - Receive a hard copy of the UISD 1:1 MLD Manual and return the acknowledgement receipt.
- After all Check-Out requirements are met, the student will receive the MLD.
- MLD will be issued through Homeroom classes.

It is the policy of United I.S.D. not to discriminate on the basis of race, color, national origin, sex, or handicap in its programs, services, or activities as required by Title VI of the Civil Rights Act of 1964, as amended; Title IX of the Education Amendments of 1972; and Section 504 of the Rehabilitation Act of 1973, as amended.

- For new students to the district, as part of the registration process, parents will receive training on 1:1 MLD Manual and will sign all District Forms.
  - MLD's WILL NOT be checked out to any student without the proper training of the 1:1 MLD Guidelines and Procedures.

#### MLD Check-in

#### Middle Schools

All devices, cases, chargers, and accessories must be returned at the end of the school year to be updated, serviced, and stored safely. Students who transfer to a District DAEP Facility or any other alternative school setting, withdraw, or terminate enrollment at UISD must return their MLD on the date of enrollment termination. MLD must be accompanied by all District issued accessories including charging cable and District issued case.

#### **High Schools**

**Upon High School graduation:** 

- Students will be given an opportunity to return the device or purchase it for a cost of \$20.
- If a student fails to return the MLD upon graduation or upon withdrawal enrollment
  - Student/parent/guardian may be subject to civil liability in order to recover or secure the cost of an MLD replacement.
  - A Police Report will be filed with the UISD Police Department.

Students transferring within UISD will return the device and accessories. Upon new campus enrollment, the student will receive their previously assigned device and accessories.

#### Alternative Schools and Withdrawal from District

Students who transfer to a District DAEP Facility or any other alternative school setting, withdraw, or terminate enrollment at UISD must return their MLD on the date of enrollment termination. MLD must be accompanied by all District issued accessories including charging cable and district issued case. Failure to return a device and accessories at withdrawal may result in the filing of a UISD Police Report as the device will be deemed stolen. Informational Technology Department will be notified and render the device useless.

District Policy States: MLD must be returned in "acceptable condition" as defined in the 19 Tex. Admin. Code §66.1310, CMD (Legal), Texas Education Code § 31.104(d), which takes into account the physical condition of the MLD and the condition of the software upon return. A fee may be assessed by campus or District administration if this criterion is not met. (CMD Legal Pgs. 8-9)
