BACKGROUND AND SIGNIFICANT ISSUES: On December 3, 2013 the Region One Education Service Center Purchasing Department received seven (7) responses to Fire, Law Enforcement, Public Safety, Security – Equipment, Supplies, Systems, and Repairs Proposal 14-11-05. This proposal allows Region One ESC and its Purchasing Cooperative members to ability to procure goods and services related to fire and public safety, law enforcement, and security. The proposal is for the period January 1, 2014 through December 31, 2015, with the option to extend up to two (2) additional one-year terms; bid tabulations are attached.
