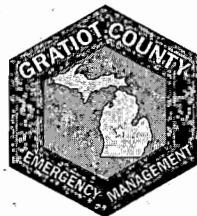

2. Structure of the Advisory Board
  - a. The lines of communication between the County and MMR shall be maintained and encouraged. To facilitate communications, MMR will work with a Gratiot County Ambulance Advisory Board consisting of the following members: one (1) from the County Board of Commissioners, appointed by the Board to staggered two-year terms; one (1) from MMR; the Gratiot County Central Dispatch Director or his/her designee; the Gratiot County Emergency Manager; one (1) from Gratiot County fire/rescue and one (1) law enforcement appointed by the Chair of the County Board of Commissioners at the beginning of each Board term; and one (1) from MyMichigan-Alma Hospital as appointed by its Chief Executive Officer.
  - b. The Advisory Board will meet at least three (3) times annually to review response times, clinical outcome data and any other necessary issues. Minutes of said meetings shall be submitted to the Gratiot County Clerk for placement on the Board of Commissioners consent agenda. Said minutes will include the response time report reviewed at the meeting.

1. - Response Times: page 2 of packets, can reasoning for late times be obtained, priority 1 (lights/sirens), patient satisfaction surveys sent out to 100% of patients transported – September 93% October 95% - 92%=Exceeds
2. Memorandum Of Understanding (MOU) to Contract between Fire Chiefs & MMR Ref Training Classes: Better system of care for the region, staffing and education, 4 new 9 in fast track MFR classes start in January in Saint Louis, other



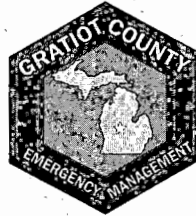
