**WHEREAS**, the Board of Education has determined that this teacher shall be dismissed for the specific reason set forth in the attached Notice of Dismissal as of the end of the 2015-2016 school term and not re-employed for the 2016-2017 school term, pursuant to Section 24-11 of The School Code of Illinois (105 ILCS 5/24-11).

**NOW, THEREFORE**, Be It Resolved by the Board of Education of Oak Park School District 97, Cook County, Illinois, that:
