Mr. Ricardo Aguilar: Mr. Aguilar has been an English teacher at Alexander High School for several years and has taken over 1500 students on educational tours to many different destinations. Mr. Aguilar suggests this experience is transformative for students. Through their travels, students discover the lifestyle and culture that exist out of their local community. After participating in these tours, hundreds of students have felt empowered with confidence, and have decide to study abroad during their collegian journey. Mr. Aguilar commended such effort and stated that if this program is approved, he will offer a one-time contribution for one student to help offset the cost and allow them to experience this great opportunity.

Ms. Melanie Soliz: As a current Senior at Alexander High School, Ms. Soliz has had the opportunity to join Mr. Aguilar on many trips. Despite the differences within herself and the other students who went on these trips, she can say that the trips changed her life. The trips are about engaging with different people from all around the world. Ms. Soliz states that she remains in contact with many of the friends she made on the trips as they continue to travel and share everything about their journeys. Education does not just take place in a classroom. Ms. Soliz said that the lessons she's learned from her travels have been invaluable. They have taught her the importance of empathy, the power of culture exchange, and the beauty of understanding people from all walks of life. These experiences have ignited in her a passion to continue exploring the world.

Mr. Victor M. Vazquez: Mr. Vazquez stated that he comes to board meetings to talk about his concerns and the concerns people put on his page and through messenger. He states that it's more of a concern than a complain. Mr. Vazquez gave various examples of concerns: the selection of the new superintendent, the 52 million dollars that Mr. Rangel said TxDOT was going to pay UISD, Chief of Police, Aaron Salazar keeping dogs for personal use, the 1.8 million for the 16 A/C units for Gonzalez Middle School, half a million dollars that was spent on a parking lot that didn't need that much improvement, 7 million dollars for elementary school built in 2003-2005 then in 2014-2016 these same blue prints were used and cost 17 million dollars, etc. Lastly Mr. Vazquez said that it is not complaining, they are all concerns.

Ms. Martha Cavazos: Recently retired from UISD as a teacher and counselor after 35 years. Ms. Cavazos was a counselor at Alexander High School for the Health and Science Magnet Program. She is here tonight to offer support for the study abroad program from a counselor's point of view. Part of her job included writing letters of recommendations and looking over student's college applications and essays. Weak resumes or essays lacking substance would create a challenge for her. Colleges are interested in students who share special experiences, they look for students that have information that sets students apart from others. Colleges not only consider grades, but the overall well-rounded student. A study abroad program would be a priceless experience, it would benefit students in many ways. They would make special bonds, friendships and gain independence, as well as becoming problem solvers. Ms. Cavazos believes that we would be robbing students from this wonderful experience, and that most importantly we would prevent them from furthering their education by limiting them. Ms. Cavazos shared an essay topic from colleges, "Tell us your story, what unique opportunity have you experienced throughout our high school career that has shaped who you are today?".

Finally, she asked Board Members to please consider this heavily, as this will impact college applications, and scholarships.

Ms. Camila Marroquin: Miss Marroquin is a Junior at Alexander High School, last year she had the opportunity to spend a year abroad in Europe. She stated that being able to live and study there was a profound transformative experience. An opportunity to study overseas is not ordinary. Such as experience leaves a mark, and leads students on a unique path towards their future.

Ms. Edna Olmeda: Ms. Olmeda directed herself to Ms. Oliveros and stated that she is speaking on assumptions, because they do advocate for students, staff, etc. Ms. Olmeda said that they never said that they didn't think it was a good idea, but rather they asked that Ms. Ramirez prioritize and find sponsors and organize fundraisers to get the funds needed for these kinds of events that she herself will be taking. She suggested that perhaps the attorneys or the Mullers or the Cigarroa's will be willing to donate. Ms. Olmeda stated that her son went on a trip with Mr. Aguilar, but it was paid by her, it did not come from the district's pocket. Ms. Olmeda also clarified that McAllen ISD had their first trip last year and is not on the third like Ms. Ramirez stated. Also, McAllen ISD did not cover any student expenses since like UISD, as they are also in a deficit. It was funded through fundraisers and a \$30,000.00 donation from McAllen Education Foundation. Ms. Olmeda asked to be transparent and not deceive the community. Lastly, she stated that as a board member it is a duty to listen and not attack the people that go before public comment forums. Ms. Olmeda states that according to TASBE the purpose of public comments at a school board meeting is to allow members of the community to voice their concerns, opinions and feedback directly to the board.

Ms. Clarissa Fraga: Ms. Fraga is a 12-year veteran of UISD and a product of UISD. Ms. Fraga stated that "It takes a village to raise a child". She said that the reason she advocates is because both present and past board members advised her to do it. Ms. Fraga advocated for justice, for driver's education, etc. She went on to congratulate the new board members and expressed hope that they listen to the people that come to advocate, she hopes they get to know them and who they really are because she feels, and se speaks for herself, that there's a lot of defamation that occurs at the district. Ms. Fraga states that there are individuals present that claim that she is just a disgruntled employee. She says she advocates for change because change is needed, but it's not being done. Ms. Fraga also advocates for employees as a TSTA Member and area representative. She goes on to state that teachers on FMLA are being harassed and are working on district holidays,

and that it can be proved. Lastly, she expressed that the district needs to stop harassing their educators.

Ms. Letty Juarez: Ms. Juarez is a former UISD teacher with over 25 years of experience. Ms. Juarez's presence is to require transparency and systematic improvement in the district. She states that unfortunately her experience seeking answers have fallen in deaf ears or has had her request forwarded to the Attorney General. Ms. Juarez states that each request sent to the Attorney General has a cost of approx. \$500 and says that It is troubling to have all these concerns not being taken seriously. She continues to quote TASBE by stating that "the purpose of public comments at a school board meeting is to allow members of the community to voice their concerns, opinions and feedback directly to the board". She states that It is troubling to hear criticism dismissed with the opinion with such discussions can harm students, on the contrary, ignoring these concerns does far more damage. Finally, she states that the remarks represent the voices of many teachers and students who are unable to speak out due to a well-founded fear of retaliation. Ms. Juarez said she will continue to advocate for everyone.

Dr. Cruz shared some of the district's initiatives, achievements and collaborations.

Dr. Cruz also reported the Kazen Elementary National Blue-Ribbon Recognition to which he, Ms. Arriaga and Kazen staff traveled to Washington DC for to receive this prestigious honor. A celebration for Kazen Elementary is scheduled for Thursday, November 21st.

He also reported that there were several UISD students that excelled in various areas. These students are part of the high school football teams, volleyball teams, the Special Education Bowling Olympics and the Superintendent's Student Advisory Council. Dr. Cruz mentioned that the Texas Education Agency had recently visited UISD to view and evaluate campuses' safety protocols. The feedback from TEA was positive, which reflects UISD's safe and secure learning environments for students and staff. He went on to elaborate that UISD's safety measures will be the exemplar for other school districts across the state.

The Superintendent also reported that United ISD has again achieved a superior rating in the Financial Integrity Rating System of Texas (FIRST). This achievement highlights the district's strong financial management practices and underscores UISDs commitment to transparency, accountability and fiscal responsibility.

Additionally, United ISD celebrated World Kindness Day with a districtwide event that brought together over 500 students from every campus to promote kindness, unity and anti-bullying.

Dr. Cruz mentioned that the district celebrated the success of the Parent Learning Summit which provided an excellent opportunity to engage with UISD parents. The event also provided valuable resources and workshops to support parents as partners in their education and their children's education. United ISD is grateful for their involvement and commitment to our student's success.

Dr. Cruz welcomed the new Board Members and mentioned that he looks forward to collaborating with them to continue the district's mission of excellence.

Finally, the Superintendent extended his heartfelt gratitude to the Board Members, staff, students, parents, ad community partners for their unwavering support and dedication to United ISD. He mentioned that he looks forward to continue to work together as the year comes to an end and the district prepares for a successful spring semester.
