Administrative Recommendation	The Crosby ISD Administration recommends approving the request to submit the application for an Optional Flexible School Day program for Crosby Crossroads Academy for the 2025 - 26 school year.
Authority for this Action	Texas Administrative Code, RULE §129.1027
Goal/Objective Addressed	Crosby ISD District Improvement Plan Goal #1: Crosby Independent School District will make academic achievement and student performance its priority.
Background	The Texas Education Agency requires the completion of an Optional Flexible School Day Program (OFSDP) application annually for any education program that seeks permission to operate outside of the normally scheduled meeting hours of the district. In this instance, the application to be submitted is for the Crosby Crossroads Academy (CCA), which is established to assist students who are at risk of not graduating, recover course credits. The approval of the completed application will provide the documentation needed to allow Crosby ISD to receive funding for the students who are enrolled in the program.
	The Crosby Crossroads Academy operates within the Crosby High School campus and serves students in grades 9-12 who are at risk of dropping out of high school. Primary emphasis is placed on grades 11 and 12 to provide students in their Junior and Senior years the ability to recover credit and meet the standards for graduation. Students enrolled in this program are provided the opportunity to attend classes on a flexible schedule, which takes into consideration life circumstances (i.e. working to meet the monetary needs of their family). Certain criteria must be met for a student to maintain enrollment. Primarily, students are required to complete 20 hours of classroom instruction per week. The
