2. Proposed 2024 Draft Tax Year Levy (Policy 4:10) – Todd Latham

Todd Latham presented the 2024 draft levy, which is composed of the Equalized Assessed Valuation (EAV), new property/construction, Property Tax Extension Limitation Law (PTELL), Consumer Price Index-Urban (CPI-U), tax rates/max rates, total extension, revenue recapture, and Truth in Taxation. The estimated 2025 tax receipts, minus the bonds and interest, are \$104,872,193 (3.53%). The tentative levy will be presented in November and the final levy and hearing in December. At the December meeting the board will vote on the Truth in Taxation Compliance Resolution, Certificate of Tax Levy, and Tax Levy Resolution.

Board comments, questions, concerns: For homes that are on the market, is there a calculation or rate that they use to determine a loss when a homeowner moves out of the district? (Taxes are set aside in the closing process, so there is no loss.) Is there a rate of people in our district that's show how many we lose or gain? (We do not lose out on any taxes when people move in or out.) So, it stays stable? (Yes.)

5. LEGISLATIVE UPDATES

Board Member Code of Conduct #8 - "I will be sufficiently informed about and prepared to act on the specific issues before the Board, and remain reasonable knowledgeable about the local, State, national, and global education issues."

Jackie Forbes shared that there is not much happening at the General Assembly until they have their two veto sessions in November. If the governor had vetoed anything prior to the November dates, then there could be a discussion and potential override of those bills. Any bills not moved to the governor's office could still be discussed in committees and moved forward. New bills are not proposed during veto sessions. After the election there will be another lame duck session.

6. SUPERINTENDENT'S REPORT (Policy 3:40)

The Superintendent shared that the district has started to plan for inclement weather, with the number one priority being in person learning.

Community Engagement is part of our Strategic Plan and Sandy Riley, who is our Communication Coordinator, has been doing an excellent job with this. Our district signed on to be part of what is called the GPS Parent Series, which is a new resource for parents this year. The fall newsletter went out this week to all parents and community members. We also have two Community Connects events coming up. The first one will be January 22 at the Geneva Public Library.

The fall is a busy time with athletic transitions, fall performances, Principal's Day, Halloween, a half day Teacher Institute Day on November 1, and Federal Election Day, which is a day off for staff and students, on November 5.

2. GHS Proposed New and Modified Courses for 2025-2026 Doug Drexler shared that planning for the 2025-26 school year has already begun. The high school is proposing changes for next year in their culinary course pathway, with one new course replacing an existing course, and another existing course being shifted from a double-period course to a single-period course. International Foods would be replaced with Gourmet Foods with students being able to earn their Food Handler's License from the Illinois Department of Public Health. Restaurant Entrepreneurship would become a single-period course, which is possible because all students enrolling in this course would already have taken the same two prerequisites. This course will also allow students to earn their Food Manager's License from the Illinois Department of Public Health. This proposal will be brought back at a future meeting for a vote.
