Re: Pizza Bid

The Pizza Bid was sent to 11 local vendors. Pizza Hut was the only vendor to send in a bid. Pizza Hut price was \$7.15 per pizza. Pizza Hut met the protein requirements based on the nutritional analysis submitted. The 2010-2011 Pizza Hut price was \$6.90 per pizza. A twenty five cent per pizza increase is reflected in the new bid price.

Based on the amount of pizzas sold during the current school year, Child Nutrition estimates that 16,000 pizzas will be bought for the upcoming school year. Pizza Hut's price would be \$114,400 for the year.

Pizza Hut has had the contract for the district's pizza business since 2008, and has shown the district excellent customer service by responding immediately to our emergency requests.
