After a motion by Jeff Ford and a second by Kindra Lucia, the Board approved the 2025-2026 Weatherford ISD Student Code of Conduct as presented. The motion passed.

Jeff Ford made a motion to approve the resolution for Parker County 4H and Palo Pinto County 4H as an extracurricular activity and the agents of both programs to be adjunct faculty of Weatherford ISD for the 2025-2026 school year. Seconded by Wally Wallace. The motion passed.

After a motion by Jeff Ford and second by Kindra Lucia, the Board voted unanimously to approve the purchase of MAP Growth as presented.

The Appraisal Calendar and Approved Teacher Appraisers was approved following a motion by Adam Feriend and a second by Wally Wallace. The motion passed.

Adam Feriend moved to approve the Certified Appraisal Roll as presented. Jeff Ford seconded the motion, and the motion passed.

Jeff Ford made a motion to award the copier service contract for the remainder of the existing lease term to Visual Edge IT. Seconded by Adam Feriend. The motion passed 6-1 with Wally Wallace voting no.

With a motion by Wally Wallace, and a second by Brian Catlin, the Board voted unanimously to approve the investment policies with no changes. The motion passed.

Adam Feriend moved to approve the Investment Broker/Dealer Vendor List as presented. Jeff Ford seconded the motion, and the motion passed.

The Board approved the annual financial report of the Parker County Appraisal District as presented following a motion by Jeff Ford, and a second by Adam Feriend.

Brian Catlin moved to approve the temporary construction license agreement with the Texas Department of Transportation as presented. Second by Kindra Lucia, and the motion passed.

The President recessed the Board into Executive Session at 8:34 p.m. to discuss Personnel.
