## General Summary or Purpose Of Job:

Under the direction of the Supervisor of Child Nutrition, provide troubleshooting support to cafeteria managers. Provides technical expertise in commercial kitchen equipment hardware and operating systems. Inspect equipment, diagnose issues, execute repair, install and perform preventative maintenance on commercial kitchen equipment as required throughout the district and provide for the safe condition and operation of all food service (kitchen) equipment in the district.

1.	Installs and configures, administers and maintains software and hardware of commercial food service equipment and operating systems	
2.	Create and maintain a periodic preventive maintenance schedule and perform all preventive maintenance and cleaning on all kitchen equipment throughout the district	
3.	Provide troubleshooting assistance to managers to resolve computer software and hardware problems of kitchen equipment	
4.	Record keeping of PM's & TM repairs	
5.	Receive, prioritize and complete work orders in a timely manner	
6.	Collaborate and advise Child Nutrition Administration and staff to effectively provide solutions to maintenance problems and repairs	
7.	Research, advise and make recommendations of new equipment purchases to Child Nutrition Administration	
8.	Make recommendations for improvements of commercial equipment	
9.	Perform equipment diagnostics and repairs when needed at each district facility
