Superintendent Search Firm Selection

The Inver Grove Heights Schools Board of Education seeks to appoint a new superintendent for the 2026–2027 school year. The Board reviewed proposals from multiple superintendent search firms, evaluated their qualifications, and identified two finalists.

A. Hazard, Young, Attea & Associates (HYA)

The first superintendent search firm to present was Hazard, Young, Attea & Associates (HYA). The firm was represented by Lead Associate Dr. Deborah Taylor. Following the presentation, members of the ISD 199 Board of Education engaged in a question-and-answer discussion with the firm.

B. Minnesota School Boards Association (MSBA)

The second superintendent search firm to present was the Minnesota School Boards Association (MSBA), represented by Director of Leadership Development and Executive Search Barb Dorn. Following the presentation, members of the ISD 199 Board of Education engaged in a question-and-answer discussion with the firm.

Following presentations from both firms, the Board held a discussion on which search firm best meets the needs of the district.
