Updates from the Business Office

FY25 Audit Update

Due to the federal government shutdown, the release of the 2025 OMB Compliance Supplement by the Office of Management and Budget (OMB) was delayed. Auditors use this supplement to review federal funding compliance. On December 1st, we received notification from the auditors that the OMB Compliance Supplement was released and the audit can now be finalized. They requested all check registers and board meeting minutes up through 12/1/25, and will move forward with preparing the final audit report. The final report will be shared with the Board once received. We do not anticipate any changes from the draft audit included with tonight's agenda.

Report to DEED: Fund Balance as of October 31, 2025

For the past two years, the state legislature has required school districts to submit fund balance data twice annually. The first report shows data as of October 31, 2025. The second report will reflect data as of December 31st. CCSD's submitted report for October 31st shows an unreserved fund balance of \$326,086, which is nearly identical to the District's budgeted beginning fund balance of \$325,525. Please keep in mind this is not a full or fair representation of the District's financial position. Many revenues and expenditures occur later in the school year, meaning the October 31st amount should not be directly compared to the District's fiscal year-end balance on June 30, 2026.

The second rquired report, reflecting data as of December 31st, will be submitted in January.

Local Foods for Schools Grant

CCSD has again received grant funding for the Local Foods for Schools (LFS) grant for the FY26 school year. The original award was \$1,530 which needed to be spent prior to September 30th. The District was recently notified of the second round of funding, estimated at \$741.55, to be spent prior to March 31, 2026. Kristine was able to purchase smoked king salmon from Wildfish Cannery with the original award, and will be on the lookout for more delicious local foods for the students to enjoy with the second round of funding.

General Fund Updates:

Please see notes below followed by the Revenue and Expenditure Overview.

- As of November 30, 2025, the district is awaiting the 3rd quarter City Proposition 2 Sales Tax revenue from the City of Craig as well as the first local contribution payment.
- The district will receive three separate payments for Pupil Transportation during the school year. The first payment of \$32,553 was received in September. The second payment is due in December which will be based on the preliminary October average daily membership after count period. The third and final payment is expected in March 2026, and will be based on the final FY26 average daily membership.
- Revenue shown below for Food Service includes only September student counts. October's payment of \$28,736 arrived in December and is not reflected in this overview. Both October and November revenue will be included in January's board report.

Local Foods for Schools FY2026 Attestation and Acceptance

The Local Food for Schools Cooperative Agreement Program (LFS) awards funds to states for food assistance purchases of domestic local foods for distribution to schools. This program will strengthen the food system for schools and childcare institutions by helping to build a fair, competitive, and resilient local food chain, and expand local and regional markets. LFS is a US Department of Agriculture (USDA) Agricultural Marketing Services (AMS) grant; in Alaska, LFS is administered by the Alaska Department of Education and Early Development (DEED).

Food purchased from this grant must be:

- Raised or produced (including harvested foods), aggregated, stored, processed, and distributed in the locality or region where the final product will be consumed. For Alaska, the definition of local is within the State of Alaska and her territorial waters.
- In a minimally processed state, meaning foods that have not been significantly processed or with
 additional additives from its original state. Examples of unallowable products would include baked
 goods such as breads, muffins, or crackers; prepackaged sandwiches or meals; other prepared and/or
 pre-cooked items that come ready-to-eat or that require no further preparation beyond heating (e.g.
 chicken nuggets, fish sticks, pre-made pizzas, etc.).

This grant may be used for the following:

- Minimally processed local foods
- Transportation costs

Grant funds may not be used for expenditures other than those explicitly stated above and specifically may not be used for:

- Administrative costs
- Indirect cost
- Processing

About the FY2026 Award and Disbursement Schedule

Available funds are distributed to eligible local education agencies (LEA) based upon geographic, access to Alaska's highway system, and LEA-wide population in National School Lunch Program (NSLP) participating schools as for October 2024. To ensure that small LEAs are not disadvantaged, all LEA enrollment counts were adjusted by adding 1,810 students to the enrollment. The adjusted enrollment was multiplied by the regional multiplier.

Region and road access are determined based upon the street address of the LEA's main office, as reported to the Alaska Department of Education and Early Development (DEED). Region and road system data was obtained from the Division of Community and Regional Affairs. Regional multipliers were based on food cost per student data obtained from each region.

The adjusted enrollments of all eligible LEAs are aggregated and the funds for each LEA are awarded by multiplying available funds by the factional total adjusted enrollment of each LEA.

Eligibility: All school districts, including Mount Edgecumbe High School, are eligible to receive LFS funds in the first quarter. To remain eligible for subsequent quarters, schools must have accepted funds in each of the previous quarters and have spent some or all of the available funds.

Period of Performance: The Period of Performance for each quarter shall begin on July 1, 2025, and end on the specified date. This means that LEAs that overspend their award in one quarter that receive sufficient award in a subsequent quarter may use funds from the subsequent quarter to pay invoices that were not reimbursed in the prior quarter.
