7A. Special Populations Update

Lisa Cochran, Director of Special Education and Section 504, highlighted the program's achievements, accountability measures, early childhood, and challenges, while also sharing some memorable moments from the year. SPED updated the technology system software into the Empower Platform that feeds into Education Modified that digitally tracks accommodations.

7B. Monthly Finance Report

Wesley Brooks presented the monthly finance report. He reported that the 25-26 budget submissions were due from campuses and departments on March 25. There are a few proposals and the state will pass a combination of salary allotment or basic allotment along with special education funding.

7D. Facility Committee Study Update

Dr. Allen briefed the board on the role the Midway Facility Study Committee will play in developing a plan that will provide direction, feedback, and guidance to the district as it addresses needs identified in the Facilities Needs Assessment conducted by Pfluger Architects. The committee consists of independent, diverse community members who will assess priorities such as facility conditions, capacity, safety, and maintenance while supporting the growth, achievement, and overall success of all students for years to come.

7E. Middle of Year Progress Monitoring Data

Kim Johnston, Director of Curriculum, presented the middle of the year progress data. The two performance tools administered are Tango LION and NWEA Map. Both assessments provide individual student progress data. The district also administers unit tests as well as early spring District Benchmark Assessment. The Midway Benchmark Assessment is intended to mirror the content and rigor level of the upcoming state assessment. The Benchmark provides guidance for final interventions prior to STAAR and EOC state assessments.

7F. 2023-2024 District Annual Report

Jess Wheeler, Executive Director, reviewed the District Annual Report which is the "final" report on the 2023-24 school year. The report includes Texas Academic Performance Reports (TAPR), PEIMS Financial Standard Report, District Accreditation Status, Campus Performance Objectives, Report on Violent or Criminal Incidents, Student Performance in Postsecondary Institutions, and Progress of the District and Each Campus Toward Meeting Board Adopted HB 3 Goals.
