President Knowles called the meeting to order at 7:01 p.m.

I. SUPERINTENDENT'S REPORT

A. Approval of Virgil Knowles as Temporary Chairperson to Convene this Meeting through Action Item IV.A.1.

A motion for approval was made by Forsyth and supported by Lohman. Motion carried unanimously.

B. School Board Recognition

Supt. O'Neill recognized the VCS School Board and thanked them for all they do to support the District.

Supt. O'Neill announced the resignation of Rick Place, Principal at Pathways HS. Rick addressed the Board and expressed his appreciation for their support of the program and its students.

C. Legislative Update

Supt. O'Neill discussed the Revenue Sharing Concensus projections. Gov. Whitmer will share the final budget information at her State of the State address, which is on January 24, 2024. It is projected that student attendance will be decreasing state-wide. So far, enrollment in Vicksburg seems to be trending in the right direction.

D. Important Dates

Supt. O'Neill directed the Board to the Important Dates listed in the packet and indicated that HS exams start next week and the beginning of the 2nd semester is on Monday, January 29th.

II. REPORTS AND PUBLIC INQUIRY

A. CTE Agreement - Steve Goss

Asst. Supt. Goss shared the draft of the Consortium Agreement that includes updates to include the CTE Center and changes to the program when that center opens. He pointed out that the State Aid stays with the resident district. Districts

will be given student slots for enrollment. VCS will be providing transportation to the CTE Center.

B. Budget and Finance Report - Steve Goss

Asst. Supt. Goss presented Monthly Budget Progress report for December 2023, showing total revenue of \$11,369,926; total expenditures of \$4,041,785 and a deficit of revenues over expenditures of \$(2,671,859).

C. Investment Holdings Update – Steve Goss
Asst. Supt. Goss presented an update on the District's investments.

D. VHS Annual Report - Adam Brush and Matt Hawkins

Principal Brush and Asst. Principal Hawkins presented the Vicksburg High School Annual Report which included highlights of student activities and events, student data and student achievements. He also recognized staff members for a great year.

III. AUDIENCE

Rev. Mak Kneebone addressed the Board regarding his LGBTQ+ journey and shared that students need support. He feels everyone is better off when all are included. As a transman, he supports VCS.
