## **Questions for President Charlie Estrada**

### **Question 1:**

“Why is it essential for parents and community members to attend school board meetings?”

(Response)

If the Board is undecided about an item or issue, information provided can help board members decide.

### **Question 2:**

“How does community involvement influence the decisions the Board makes for students and staff?”

(Response)

### **Question 5:**
