THE CITY OF DENTON PIONEERS SETTLED THIS LOCALITY IN THE 1840S. IN 1846 THE TEXAS LEGISLATURE CREATED DENTON COUNTY-1846 THE TEXAS LEGISLATURE CREATED DENTON COUNTY GRANT. ONE OF SEVERAL CARVED FROM THE PETERS COLONY GRANT. AFTER TRYING OTHER SITES, THE VOTERS IN 1856 ACCEPTED FOR COUNTY SEAT THIS TRACT DONATED BY HIRAM CISCO, WILLIAM LOVING, AND WILLIAM WOODRUFF. THE CITY AND COUNTY WERE NAMED FOR JOHN B. DENTON (1806-41), A MINISTER KILLED WHILE DEFENDING FRONTIER SETTLERS.
