The Policy Committee's charge is to perform orderly and continuous review of existing policies and to make policy recommendations to the Board to ensure consistency with the District Mission, Vision, and best practices relating to the following:

1. Section 0000 Philosophy, Goals, Objectives, and Comprehensive Goals
2. Section 1000 Community Relations
3. Section 2000 Administration
4. Section 3000 Business and Non-Instructional Operations
5. Section 4000 Personnel
6. Section 5000 Students
7. Section 6000 Instruction
8. Section 7000 New Construction
9. Section 8000 Site Councils (ARCHIVED: 1/13/2021)
10. Section 9000 Bylaws of the Board

11. Section 10000 Charter Schools

The Committee also works with the District Administration to monitor changes affecting public education and considers new policies, or policy revisions, to deal with those changes. The committee also uses updates and recommended changes to policies from the Association of Alaska School Boards (AASB) in an effort to maintain legal compliance with state and federal law. The committee makes policy recommendations to the full School Board for consideration.

The District considers the following components or "look-fors" within the context of policy review:

- 1. Ensuring that options found in existing or model policies are chosen (Option 1 or Option 2);*
- 2. Policy implementation considerations (resources, practicality);*
- 3. Consistency among policy references and terms; and*
- 4. Practice vs. policy considerations (i.e. Do they match?)*

The review cycle below was revised and approved by the School Board in April 2017 (Year 0). Sections of the policies are to be reviewed on a continuous rotating schedule as follows:
