


Percentage of Student Eligibility Status Pre-K to 12th Grade (Free and Reduced)



District percentage of Directly Certified students for 2019-2020 is 35%, which is the determination factor for the Community Eligibility Program.




Percentage of Student Daily Participation Pre-K to 12th Grade - Breakfast

 - Negative balance letters sent home with PK 6th grade students
 - Negative balance letters sent by mail to TMS and THS students
 - Cafeteria managers call parents/guardians

School Nutrition Bids – Cost Savings

- Milk:
 - The milk bid is saving the District approximately \$25,000 per year below the MDE Child Nutrition State pricing.
- Dish machine:
 - Dish machines to all cafeterias are supplied at no cost to the District.
 - The machines are serviced and maintained at no cost to the District.
 - Chemical pricing is below MS state contract pricing.
- Produce:
 - Weekly Price Quotes on produce from local vendors:
 - Cockrell Banana Tupelo
 - 2018 2019: \$71,640.66
 - 2019 2020: \$65,504.33
 - United Produce Starkville
 - USDA Commodity Produce FFAVORS program
 - 2018 2019: \$40,514.25
 - 2019 2020: \$28,161.95.
 - Temporary Staffing:
 - Began 2019 2020 school year and is in current use.
 - The cost savings to the District is yet to be determined.


