 - Grants-
 1. Title 1a is a federal program managed by the state. It is for low income- <40% free/reduced lunch; goes toward aide time, supplemental curriculum programs such as IXL, Flocabulary, etc...
 2. Preschool Grant—On the chopping block with state budget. Priscilla mentions that the preschool kids don't "count" don't our school count. Chad reiterates how important early childhood education is. Sheri explains that the preschool program is extremely important and the preschool students will count eventually as they grow into Kindergarteners.
 3. Gifted Program—Sheri brings up the gifted program and other programs to help students below level get caught up. Priscilla will look into the Gifted Programs, as not much is known. Asks what a below level program would look like, Sheri says to have the ability to teach the kids where they are, not where they should be.
 4. Title 1c- Migrant Ed: families who fish (commercial or subsistence), who are gone for 7 days/nights—does not have to be consecutive. Once enrolled, enrolled for 3 years: Migrant summer camp again this year, paid for with grant
 5. Title V- Student support and Academic Achievement (\$10,000) is very broad. Can be used for well rounded education, but needs parent input. Last 2 years has been used for Dancing with the Spirits.
 6. POW Health Network will donated \$3,000, grant written for \$4,000, and another getting written for \$20,000.

Sheri would like to see grants be looked at and pursued for Mental Health Programs. Grants are available for small communities. Through the years, funding has gone to different programs, especially the greenhouses. It is can be an important resource, but it

is not being used as intended. It is being used as a business to try and turn a profit. With a focus on profits, the educational value has been lost with the greenhouses. The focus should shift to start providing mental health programs. Need to spend more time searching for Mental Health Grants. Phlight Club 2x year is not enough and does nothing for younger students. With the new administration, hope mental health is a priority.

Should also look for a school counselor.
