Title: 2026-2027 Capital Improvement Bid Results and Approval

Background:

Each year Geneva Community Unit School District 304 pursues capital improvements as outlined in our capital plan and approved by the Board of Education in the annual budget. On October 9, 2025, the district issued requests for bids for capital projects to be completed in the summer of 2026. The work for this bid period includes Interior/Exterior, Mechanical, Plumbing, Electrical, and Site upgrades to the High School, Middle School North, Middle School South, Mill Creek Elementary and Transportation Building. Specifically, the resulting construction will

1. Remove and replace the tennis courts, replace paving and striping of the main High School parking lot and related sidewalks. Reglaze the Greenhouse at the High School, along with replacing the epoxy floor.
2. Remove and replace Boilers and associated pumps at Middle School North, along with Health Life Safety upgrades.
3. Upgrade Fire Alarm systems at Middle School South, as well as Health Life Safety upgrades, and replacement of Window Shades.
4. Tuckpointing and cleaning of the exterior masonry at Mill Creek Elementary.
5. Replacement of a service pit cover at the Transportation Building.

These capital improvements are designed to meet Geneva CUSD 304 standards of quality. A summary of Bid Period #1 bid packages as follows:
