#### **Public Content**

The Department of Elementary and Secondary Education (DESE) issued Commissioner's Memo COM-24-066 - Inclement Weather Make-up Day Guidance on January 25, 2024. This memo grants school districts to change their calendar designation, necessitating a waiver to A.C.A.§ 6-10-106 which mandates submission of calendar designations to DESE by July 1.

The state offers four (4) calendar options to districts. Bentonville Schools Board of Education (BOE) approved the Personnel Policy Committee's (PPC) recommendation for a traditional calendar option for the 2023-2024 school year during its January 2023 meeting. Both licensed and classified PPCs reviewed the option to move the current calendar to an alternative calendar which requires 1,068 instructional hours and 30 hours for inclement weather to be established in the calendar. Both Classified and Licensed PPC voted to approve the waiver to change the 2023-2024 calendar from a traditional calendar to an alternative calendar. The 2023-2024 Draft Alternative Calendar was approved by both Licensed and Classified PPC and is attached with this memo.

Additionally, Licensed and Classified PPC reviewed the 2024-2025 traditional calendar that was approved during the January BOE meeting and voted to approve a change from a traditional calendar to an alternative calendar. The 2024-2025 Draft Alternative Calendar is attached to this memo.

The Personnel Policy Committee presents the following motions for approval:

Approval of the *Inclement Weather Calendar Waiver Request* to allow the District to transition to an alternate calendar requiring 1,068 hours of student instruction and an additional 30 hours of student instruction to be used for inclement weather.
